## MS PROGRAM IN REGULATORY AFFAIRS

#### **Background**

Our MS Program in Regulatory Affairs is a fully-online, self-supported program that receives no funding from the State of California. The fees for the 39 unit MS degree are currently \$850 per unit, which totals \$2,500 for a 3-unit course and \$33,150 for the entire MS program. This is a significant investment for students, who are, for the most part, working professionals with family commitments. Some students work for large employers that have funds available for education and offer partial reimbursement of fees at the completion of a course. However, many students do not have this benefit, and it is those student applicants for whom the scholarship has made the largest impact.

We offer five 9-week accelerated sessions each year — two per semester and one in the summer. Most students take one course each session, completing the program in 2.5 years.

#### **Impact on 2018 Recipients**

The recipients of the scholarship in 2018 were Bryan Read and Connor Dowdy.

“The AMDM Scholarship that I received was hugely beneficial to me personally. I was awarded the scholarship at the end of the program when I was focused on finishing up my last class and the capstone project. With the aid of this scholarship I was able to completely focus on the coursework and completing the tasks at hand instead of worrying about paying off the semester’s tuition.

I did not take out any loans, and I did not receive any tuition reimbursement from my employer, so I was paying for the tuition out of pocket. This scholarship immensely helped with the financial burden that I was under.
